

## CERTIFICATION OF INABILITY TO OPERATE DUE TO LACK OF QUORUM

In accordance with Executive Proclamation JBE 2020-30 and 2020-33, issued by Governor John Bel Edwards, this notice shall serve as certification of the Plaquemines Parish Council, in both its capacity as the governing authority of Plaquemines Parish Government and as the governing authority of the Plaquemines Port, Harbor and Terminal District will be unable to operate due to lack of a physical quorum as a result of the COVID-19 pandemic and the above referenced Proclamations.

Pursuant Section 4 of JBE 2020-30, both the Plaquemines Port, Harbor and Terminal District Board of Commissioners and the Plaquemines Parish Council will have its members attend their respective meetings at 5:00 pm, and following, on April 23, 2020, via the internet platform ZOOM and streamed live on YouTube. The Plaquemines Parish Council consists of 9 members and thus the attendance of the Council, as well as its essential staff, the essential staff of the Plaquemines Port, Harbor and Terminal District, the Parish President and the essential staff of Plaquemines Parish Government make a physical meeting impossible under the above cited Proclamations, with specific reference to the prohibition of gatherings of 10 or more, and the generalized stay at home order.

In accordance with guidance on the Open Meetings Law by the Office of the Louisiana Attorney General, members of the public will be allowed to view the conduct of the meeting through the ZOOM platform and via live stream on YouTube will be allowed to make public comment on the pertinent agenda items through the use of an email address, as set forth in the notice of the meeting that will be posted on the Parish and Port websites and posted at the Council chambers at 18055 Highway 15, Pointe-a-la-Hache, LA.


