Council Member LaFrance moved to Agenda Item 3, "Ordinances and Resolutions on Second Reading and Final Passage". Without objection, so ordered.

On motion of Council Member LaFrance, seconded by Council Member Cognevich, and on roll call, all members present voting "YES", except Council Member Cognevich who "ABSTAINED", and Council Members Black and Guey who were "ABSENT", Resolution No. 20-111, entitled, "A Resolution to direct Parish Special Counsel, Brandon J. Taylor of Cossich, Sumich, Parsiola & Taylor, LLC, to accept all pending Eligibility Notices, not to appeal any pending Denial Notices, and not to appeal any forthcoming notices, Eligibility or Denial, as issued by the Claims Center for the Parish's Halliburton/Transocean (HESI) Class Settlement Claim; and otherwise to provide with respect thereto", was adopted by a vote of 6-0-1.

Council Member LaFrance reverted back to Agenda Item 2, "Building Permits". Without objection, so ordered.

On motion of Council Member Blink, seconded by Council Member LaFrance, and on roll call all members present and voting "YES", except Council Members Black and Guey who were "ABSENT", Resolution No. 20-112, approving the issuance of a Coastal Zone Management permit to Daybrook Fisheries, Inc., Application No. P20181345, dated April 29, 2020, to dredge and maintenance operations, Daybrook Fisheries Facility, 136 Daybrook Road, Empire, LA, was adopted by a vote of 7-0.

There being no further business to come before this Council, on motion Council Member Rousselle, seconded by Council Member LaFrance, and on roll call all members present and voting "Yes", except Council Members Black and Guey who were "ABSENT", the meeting adjourned at 11:14 a.m.
