Sandy Sanders, Paul Matthews, Christie Nielsen, Chambrel Riley and Donald Durr were present to represent the Port.

The Prayer said and the Pledge was recited.

The following items were deferred:

- 6b, “An Ordinance of the Plaquemines Parish Council acting as the Sole Governing Authority of the Plaquemines Port, Harbor and Terminal District to authorize and direct the purchase of the Popich Building from Plaquemines Parish Government; and otherwise to provide with respect thereto” was offered by Commissioner Black and seconded by Commissioner Guey for discussion only. A discussion was held and then the matter was deferred;
- 6c, “ A Resolution authorizing Maynard “Sandy” Sanders, as Executive Director of the Plaquemines Port, Harbor & Terminal District, to extend the agreement with Trident Holdings, Inc., for the implementation of the Port’s Master Plan; and otherwise to provide with respect thereto”; and
- 6i, “A Resolution authorizing Maynard J. “Sandy” Sanders, Executive Director of the Plaquemines Port, Harbor & Terminal District to enter into an agreement for Business Consulting services focusing on the Port’s Procurement Policy with _____ for the improvement and possible development of a new policy; and otherwise to provide with respect thereto” was offered by Commissioner Blink and seconded by Commissioner Arbourgh. A discussion was held and then the matter was deferred.

There being no Executive Session, Commissioner Blink moved to Agenda Item 3, “Status Report by the Executive Director”. Without objection, so ordered. Sandy Sanders reported the following:

- A meeting was held with the Rio Grande Railroad and the New Orleans & Gulf Coast Railroad regarding the first stage grant in the amount of \$18,000,000 of which \$9,000,000 will be used for existing repairs on the current line in Westwego. Then a \$350,000,000 grant will be used to move the line out of Gretna and around the Naval Air Station;
- The Port staff continues to meet virtually once a week while coming into the office on an as needed basis. General Sanders commended his staff on jobs well done; and
- The rescue boats continue to be fully staffed. Also, there was an Administrative error with the computer in the Port Conference room so they quickly switched to a laptop in order to join the meeting.

Commissioner Blink moved to Agenda Item 3a, “Finance Report/Budget to Actual”. Without objection, so ordered. Chambrel Riley stated that the Commissioners received the 2020 Total Budget and Budget Performance reports as of May 13th. The General budget total expenditures were below the budgeted amount. The Rescue Boat budget remained on point with the budgeted amount. There was an 10% increase in invoicing in March 2020 as compared to March 2019; however, there was a decrease in April 2020 compared to March 2020 which she attributes to COVID-19. Extra measures will be implemented for 100% reporting status from Port customers.

The 2020 Port Security Grant projects have kicked-off with bids being received for cyber security, camera upgrades and GIS implementation.

There being no Bids and Advertisements, Commissioner Blink moved to Agenda Item 5, "Introduction of Ordinances and Resolutions". Without objection, so ordered. The following items were introduced:

An Ordinance authorizing the Plaquemines Port, Harbor & Terminal District (the Port), to accept funds from Port Security Grant Program #EMW-2019-PU-00030 for MSOC Security Systems, Surveillance Cameras, GIS Acquisition & Implementation and Security equipment; and otherwise to provide respect thereto. COMMISSIONER BLINK

Commissioner Blink moved to Agenda Item 6, "Ordinances and Resolutions on Second Reading and Final Passage". Without objection, so ordered.

There were no items under 6a.

At the request of Commissioner Black, Commissioner Blink moved to Agenda Item Under 7b, "Presentation and discussion by Director Todd Eppley regarding parish owned real property, specifically the Popich Building. Commissioner Black gave the floor to Mr. Eppley to make a presentation. He provided a spreadsheet containing figures based on information from commercial real estate professional for the rental of the 2nd floor of the Popich Building based on both \$12.00 and \$10.00 a square foot. Discussions were had regarding the possible rental income versus the monthly expenses for insurance, power, cleaning, etc. Commissioner Black spoke regarding the Parish's need for cash and the possible benefits of selling the building due to the risk of renting and still coming up with a deficit. The time frame on moving the 911 center from the Popich Building to the Government Complex was discussed and that would be about a year away according to President Lepine.

ORDINANCE NO. 20-35

The following Ordinance was offered by Commissioner Blink who moved its adoption.

WHEREAS, the Port has a statutory mandate to promote the safety and security of the river, river-front, docks, wharves, navigable waterways, vessels adjacent to or away from docks and wharves, as well as the banks, battures and contiguous and adjacent area affected by port, harbor, terminal, water and marine activities within the Port's jurisdiction; and

WHEREAS, the Port has applied for and been awarded Port Security Grant Program Funds for a total project cost of \$569,750.00; and

WHEREAS, Port Security Grant Program funds in the amount of \$427,313.00 representing 75% Federal Funding available for this purpose; and

WHEREAS, the Port is required to contribute a 25% cost match in the amount of \$142,437.00;

NOW, THEREFORE:

BE IT ORDAINED BY THE PLAQUEMINES PARISH COUNCIL AS THE SOLE GOVERNING AUTHORITY OF THE PORT, HARBOR & TERMINAL DISTRICT THAT:

SECTION 1

The Plaquemines Port, Harbor & Terminal District is hereby authorized to accept Port Security Grant Program funds in the amount of \$427,313.00 from Grant #EMW-2018-PU-00023.

SECTION 2

The Plaquemines Port, Harbor & Terminal District acting through the Port Executive Director, is hereby authorized to proceed with signing any and all documents necessary to carry out the completion of this project.

SECTION 3

The Secretary of this Council is hereby authorized and directed to immediately certify and release this Ordinance and that Port employees and officials are authorized to carry out the purposes of this Ordinance, both without further reading and approval by the Plaquemines Parish Council.

Council Member Arbourgh seconded the motion to adopt the Ordinance.

President Lepine and the three Charter Directors, Todd Eppley, Crystal Taylor and Scott Rousselle were present representing the Administration.

There being no items for Executive Session and no proclamations, Council Member LaFrance moved to Agenda Item 4, “Status Report by the Parish President”. Without objection, so ordered.

President Lepine reported the following:

- Conference calls with public officials are still being held every Friday at 10:00 a.m. and he invited all the Council Members to join in;
- The Parish curfew is being lifted tonight; and
- Tomorrow Phase I of the reopening of the Parish begins and it will mirror the Governor’s proclamation. President Lepine stated we will be operating responsibly and that safety is our number one priority.

Council Member Rousselle had one item of discussion under the President’s Update entitled, “Discussion regarding the recent mailers with the cable bills citing the franchise authority and Legal Department action”. Council Member Rousselle stated that Mr. Helmers sent an email regarding this topic to the Council Members. He went on to ask Mr. Helmers if the franchise agreement terminated in 2015 and Mr. Helmers confirmed that it did. Council Member Rousselle went on to ask what would have happened if we had renewed the franchise agreement before it was terminated and he was told by John Helmers that the Parish would have had more leverage with the cable company. Mr. Helmers went on to say that new cable company is requesting a State franchise which is at 5%. The State will send the 5% to the Parish without taking out any administrative fees.

Council Members Rousselle and Black then made some comments relative to the current budget crisis. Council Member Rousselle stated that legislative to borrow money is on the agenda to be voted on today. Meetings were held to discuss budgetary issues wherein the Council Members were told that the Administration was working on a plan and he wanted to know if that plan was going to be revealed any time soon. President Lepine stated they were working on the plan but if the Council did not vote for the said legislation, the Administration would be coming back to the Council in August or September for more money. Council Member Black said that he agrees with Council Member Rousselle about the necessity of the Administration to come up with a plan; however, he believes the onus now lies with the Council. He went on to say that we know what the issues are and its time for us seriously look at them.

Council Member Newberry thanked President Lepine for the Second Harvest’s food distribution held in the Parish and for having the Parish workers help distribute the food. She also thanked her Assistant, Stephanie Miller for helping. President Lepine said it was a success and more distribution dates will be posted soon.

Council Member Barthelemy joined the meeting at 7:18 p.m.

BE IT RESOLVED BY THE PLAQUEMINES PARISH COUNCIL THAT it request the CPRA adjust the freshwater diversions in and around Lake Leery, Spanish Lake and Grand Lake, as well as in the upper marshes on the East Bank of Plaquemines Parish, in order to keep the salinity in these areas at 5 to 15 parts per thousands year-round.

BE IT RESOLVED BY THE PLAQUEMINES PARISH COUNCIL THAT the Secretary of this Council is hereby authorized and directed to immediately certify and release this Resolution and that Parish employees and officials are authorized to carry out the purposes of this Resolution, both without further reading and approval by the Plaquemines Parish Council.

10g, “District 7 update”: Council Member LaFrance thanked the Council Members for handling their business in a professional manner and asked for anyone who would like to have a Budget Review to contact him and he would be happy to call a meeting.

At the request of Council Member Barthelemy, Council Member LaFrance reverted back to Agenda Item 10f, “District 1 update-“Update on East Bank levees”. Council Member Barthelemy thanked Director Scott Rousselle for fixing the levee culverts in order to get it back into the Federal Levee system. He further expressed his concern with the northern end of the back levee which needs to be repaired.

Council Member LaFrance moved to Agenda Item 11, “Approval of Minutes”. Without objection, so ordered.
