

Minutes of a meeting of the Plaquemines Parish Council, as the Sole Governing Authority of the Plaquemines Port, Harbor & Terminal District, held in the Pointe-a-la-Hache Courthouse Council Chambers, 18055 Highway 15, Pointe-a-la-Hache, Louisiana on Thursday, May 27, 2021, at 3:00 p.m., pursuant to notice to all members with a quorum present as follows:

Sandy Sanders, Paul Matthews, and Chambrel Riley Williams were present to represent the Port.

The Prayer was said and the Pledge was recited.

There being no matters to address under Agenda Item 2, "Executive Session", Commissioner Blink moved to Agenda Item 3 "Status Report by the Executive Port Director". Without objection, so ordered. The following was reported:

- Notice was received from the CORPS that permit for B-3, the last remaining obligation to VG, has finally been received;
- The Port met with the lead team from a leading warehouse, inc. and logistic company whose name cannot be revealed; however, they expressed interest in the container project. Talks are ongoing; and
- The Port entered into a MOU with AP Moor Terminals, the second largest terminal operator in world. The MOU kicks off a 120 day due diligence period where AP Moore will review the port's proposition and evaluate their interest. The AP Moore team was here this week and they met with Board members. They are not only interested in being a terminal operator, but also investing in the terminal.

Commissioner Blink moved to Agenda Item 3b, "Financial Report/Budget to Actual". Without objection, so ordered. Chambrel Riley Williams stated the Council Members have been provided a 2021 Total Budget Report and Detailed Budget Report with Actual Expenditures as of April 30, 2021. A subcategory budget has been provided also. Tariff revenues are 4% ahead of budget; Legal Support is 9% over budget at this time and Total Operating Expenses are 17% below budget.

Commissioner Rousselle stated that Legal Expenses was an item he has been raising a red flag on since beginning of the year. Rousselle asked if the Port had a strategy on how to reel the Legal expenditures back into the budget. Sandy Sanders said yes; however, there is an ongoing need for legal services and we will probably come to the board to ask for an increase in the budget. There was then a discussion held between members of the public, the Council and the Port Administration about posting the budget on the Port website versus the Port requiring Public Records Requests for budget information.

Commissioner Blink moved to Agenda Item 4, "Bids and Advertisements". Without objection, so ordered.

Commissioner Blink offered 4a with the blanks filled in.

ORDINANCE NO. 21-51

The following Ordinance was offered by Commissioner Blink who moved its adoption:

An Ordinance to amend and as amended the Plaquemines Parish Port, Harbor & Terminal District 2021 Operating Budget of Revenue and Expenditures; and otherwise to provide with respect thereto.

WHEREAS, the 2021 Operating Budget of Expenditures is amended to reflect the estimated cost for agreement between the Port and Kyle Associates LLC approved by Resolution No. 21-96; and

WHEREAS, Resolution No. 21-96 approved the Executive Director to enter into a professional service agreement for the purposes of performing planning, scoping, engineering design, environmental, permitting, preparation of specifications and construction bid packages, and other related services for the upgrades to Plaquemines Parish Waterline and Booster Station; and

WHEREAS, the Plaquemines Parish Port, Harbor & Terminal District 2021 Operating Budget of Revenue and Expenditures is amended to reflect the estimated cost for engineering and design services to support construction of enhanced infrastructure in Plaquemines Parish by appropriating \$250,000 from the Port's Land Fund is requested;

NOW, THEREFORE:

BE IT ORDAINED BY THE PLAQUEMINES PARISH COUNCIL AS THE SOLE GOVERNING AUTHORITY OF THE PLAQUEMINES PORT, HARBOR & TERMINAL DISTRICT THAT:

SECTION 1

Plaquemines Parish Port, Harbor & Terminal District 2021 Revenue and Expenditure Budget is hereby amended by transferring \$250,000 from the Port's Land Fund balance to Professional Services-Engineering and Design Services in the Expenditure Budget.

## SECTION 2

The Secretary of this Council is hereby authorized and directed to immediately certify and release this Ordinance and that Port employees and officials are authorized to carry out the purposes of this Ordinance, both without further reading and approval by the Plaquemines Parish Council.

WHEREUPON, in open session the above Ordinance was read and considered section by section and as a whole.

Commissioner Newberry seconded the motion to adopt the Ordinance.
